

CSWL Data Protection Notice

Last revised: August 2024

1. Scope of the Notice

This CSWL Data Protection Notice (hereafter the “**Notice**”) outlines how the Luxembourg House of Cybersecurity (hereafter “**LHC**” or “**we**”) collects, processes and protects personal data in relation to the **CYBERSECURITY Week Luxembourg**¹ (hereafter the “**Event**” or “**CSWL**”) in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (“**GDPR**”).²

2. Data Subjects

This Notice is intended for:

- Event Participants;
- Event Speakers;
- Event Sponsors.

3. Data Controller

5. Purposes and legal basis for processing

LHC collects and processes the Data Subject's personal data for the following purposes:

(1) Event management:

LHC processes personal data for such purpose under LHC's **legitimate interest** in organising and deploying the Event. The processing of such personal data is based on the Data Subject's **consent** as per art. 6 (1)(a) of the GDPR.

(2) Processing of contact details for inviting Data Subjects to future events:

Consent provided during the Event registration as per art. 6 (1)(a) of the GDPR. To withdraw consent, the Data Subject can contact LHC at info@lhc.lu

(3) To perform and execute agreements:

The processing of personal data is necessary for the execution of a **contract** with Sponsors, Speakers and remaining Participants purchasing registrations for the Event. After the Event, in case of financial transactions, LHC will need to process personal data to **comply with legal obligations**.

6. Categories of personal data

The following contact data are collected:

- Contact details (first name, last name, role, organisation, country, e-mail).
- Signatures in case of executed contracts with Speakers or Sponsors.
- Recorded (audiovisual material) presentations, talks and interventions from Speakers and panelists.

7. Retention period

Contact data collected will be kept by LHC for one year after the Event.

8. Transfers of personal data:

The processing of personal data, in this context, does not include the transfer of personal data outside the EU/EEA.

9. Data Subjects' rights

With regards to the personal data collected and processed by LHC, the Data Subject may exercise at any time the following rights:

- **Right to access:** right to receive confirmation about whether or not its personal data is being processed by LHC. If that is the case, the Data Subject has the right to know what data is being collected and processed and to obtain a copy of it;
- **Right to rectification:** if the personal data that LHC holds about the Data Subject is inaccurate or incomplete, the Data Subject has the right to request to have it rectified;
- **Right to erasure:** subject to certain conditions specified in art. 17 of the GDPR, the Data Subject has the right to have its personal data deleted by LHC;
- **Right to restriction of processing:** subject to certain conditions specified in art. 18 of the GDPR, the Data Subject has the right to obtain restriction of the processing of its personal data performed by LHC;
- **Right to data portability:** subject to certain conditions specified in art. 20 of the GDPR, the Data Subject has the right to obtain a copy of the personal data you provided to LHC in a structured, commonly used and machine-readable format and to request the transfer of these data to another data controller;
- **Right to object:** the Data Subject has the right to object the processing of its personal data when the conditions set out in art. 21 of the GDPR apply;
- **Right to withdraw consent:** if LHC is processing the Data subject's personal data based on consent, the Data Subject has the right to withdraw that consent at any time. The

withdrawal of such consent shall not affect the lawfulness of processing based on consent before its withdrawal.

- **Right to lodge a complaint with a supervisory authority:** the Data Subject has the right to lodge a complaint with the [Commission Nationale pour la Protection des Données](#) ("CNPD").

10. Amendments to the Notice

LHC reserves the right to amend this Notice from time to time to reflect changes in laws, data collection and practices, and to ensure its accuracy, completeness and timeliness. LHC encourages the Data Subjects to check this Notice regularly.
